It's...Alive?

Pinally, the 2024 First in the NationTM Presidential Primary Election® is showing signs of...life?

The suspense is over; the date has been set: New Hampshire's favorite pastime, its quadrennial civic extravaganza, will come to a dramatic conclusion on Tuesday, January 23rd.

If it's alive, though, what's up with those neck bolts? In all seriousness, we should probably add an asterisk to the typographical fruit salad which traditionally encumbers our textual references to the presidential primary.

According to the Democratic National Committee, New Hampshire will not be holding a primary. Oh, we can do whatever we like of course, this being a free country. The DNC says our primary won't count, though, because Secretary of State David Scanlan set the date too early.

President Biden agrees with the DNC, naturally. It was his idea to let South Carolina hold the first primary. His, and Rep. James Clyburn's [D-S.C.]. Americans Are Bankrolling Israel's Unfolding Genocide in Gaza

mericans are funding a geno-Acide and no one asked our permission.

We are being dragged, unwillingly, into a war that is decimating a people. We are being forced to become involuntary accomplices to mass slaughter.

Palestinians, on the basis of their legal right against being wiped out, have filed a major lawsuit against President Joe Biden's administration for funding Israel's ongoing pogrom in Gaza, one that has killed more than 11,000 people, including 4,700 children. Represented by the Center for Constitutional Rights (CCR), the plaintiffs include Palestinians who have collectively lost at least 116 family members to U.S.-funded Israeli military attacks.

The U.S. has sent Israel a total of about \$317 billion in inflation-ad-

justed tax-payer money, which amounts to more than \$4 billion annually. Almost all that funding has gone toward the Israeli military. Israel is the largest recipient of American foreign aid, receiving more money than what we give to far larger, far poorer nations, ones that have a far greater post-colonial claim to Western aid.

Now, the U.S. Congress and the Biden administration want to give even more of our tax dollars to Israel, specifically to continue bankrolling the unfolding genocide. They are quibbling over the political strings attached to the aid but are united in their desire to send the supplemental

But, according to CCR, "The United States has a duty under Article 1 of the Genocide Convention to prevent and punish acts of genocide, an obligation the U.S. Congress made law in 1988." It's not just the

number of dead Palestinians that ought to result in a withholding of U.S. aid but the fact that Israeli officials have been overt about their genocidal aspirations.

The lawsuit offers evidence of how various Israeli politicians have referred to Palestinians with dehumanizing language such as Defense Minister Yoav Gallant, who promised that the "human animals" in Gaza would suffer the consequences of his order for "a complete siege on the Gaza Strip," resulting in "no electricity, no food, no fuel."

Days into Israel's bombing campaign, United Nations Special Rapporteur Francesca Albanese warned on October 14, 2023, of a grave danger of ethnic cleansing of Palestinians, saying, "The international community has the responsibility to prevent and protect populations from atrocity crimes." Referring to the first great displacement that Pal-

estinians suffered, Albanese added, "There is a grave danger that what we are witnessing may be a repeat of the 1948 Nakba, and the 1967 Naksa, yet on a larger scale."

At the time Albanese made the warning, Israel had killed 1,900 Palestinians.

A month later, on November 13th, Israel's Agriculture Minister Avi Dichter described his nation's bombing campaign with a concise phrase, worthy of an operational name for planned genocide: "Gaza Nakba 2023. That's how it'll end."

By then the official death toll of Palestinians was more than 11,000. United Nations experts warned that "the Palestinian people are at grave risk of genocide," and, added, "Israel's allies also bear responsibility and must act now to prevent its disastrous course of action."

One journalist named Chris McGreal, wrote in *The Guardian*, "I covered the Rwandan genocide as a reporter. The language spilling out of Israel after the butchery of the Hamas attacks is eerily familiar." McGreal also correctly called out U.S. elected officials such as Senator Lindsey Graham for picking up the pitchfork and joining the violent mob. "We are in a religious war here. I'm with Israel. Do whatever the hell you have to do to defend yourself. Level the place," said Graham.

It's a simple calculus: Israeli officials promise to wipe out people who they view as less than human, with the full blessing and financial might of the U.S. The predictable outcome is a fulfillment of their promises, one that is happening in real-time. Not only are politicians responsible for Palestinian genocide, but so too is the media for uncritically reporting

on the explicit goals and desires of genocidal maniacs.

Why shouldn't we believe leaders when they tell us exactly who they are and what they intend to do? History is replete with naïve denials of stated intentions to violate human decency even as crimes unfold in plain sight. Recall that when Donald Trump told the nation in 2015 that he would launch a white supremacist presidential bid media outlets refused to call him a racist until several years later after the damage was done and he was in the White House. Hate crimes surged against Black people, Latinos, Muslims, and Jews. It wasn't until the summer of 2019 that media outlets finally decided it was okay to label him a racist—that too after much hand-wringing. About a year and a half later, Trump mobilized an attack on the U.S. Capitol in January 2021 in what legal experts describe as an "insurrection" by a majority white mob. Trump told us who he was. Mainstream media outlets refused to believe him until it was too

We're seeing a familiar hand-wringing today. Take the *New*

York Times's insistence on using euphemisms like "extremist," "incendiary," and "inflammatory" to avoid describing Israeli officials' language and the Israeli military's actions as generidal

This type of discussion dilutes an understanding of Israel's stated goal by attempting to grapple with the technical definition of genocide. For example, Omer Bartov, a professor of Holocaust and genocide studies at Brown University wrote in a November 10th New York Times op-ed that, "I believe that there is no proof that genocide is currently taking place in Gaza." Still, Bartov admits that his "greatest concern watching the Israel-Gaza war unfold is that there is genocidal intent, which can easily tip into genocidal action." (Notice how he doesn't say "Israel has genocidal intent"—a common use of the passive voice to dilute blame.)

Countering this concern in comments to Vox, Raz Segal, an associate professor of Holocaust and genocide studies at Stockton University asked, "How many Palestinians need to die for these statements [by Israeli officials] to be recognized as what they are?"

It is the job of journalists to warn against abuse, exploitation, and



corruption, and to shine a light on power so that an informed citizenry can decide on the course of its government. Many journalists are indeed speaking out against sidestepping the responsibility to report on genocide. More than a thousand have signed on to a letter saying they "hold Western newsrooms accountable for dehumanizing rhetoric that has served to justify ethnic cleansing of Palestinians."

That ethnic cleansing is in full force. CCR's lawsuit is seeking an injunction to immediately block U.S. tax dollars from supporting Israel's war in a concrete effort to block the genocide, or at least wash the stain of Palestinian blood off American hands. Meanwhile, public support for U.S. aid to Israel has dropped, with more Americans now opposed to the military assistance than supporting it according to a Reuters-Ipsos poll. Nearly 70 percent support a ceasefire.

International leaders, government offices, and media institutions, often ignore or deny genocides as they are unfolding, express regret after it's too late, and then make promises of "Never again." When warning signs of the next genocide arise, the cycle repeats. It's up to us to stop it and we have that chance right now.

House GOP to Hold Hearing on Social Security 'Death Panel' by Jake Johnson

The Republican-controlled House Budget Committee convened a hearing Wednesday to examine legislation that would establish a so-called fiscal commission for the U.S. debt, a proposal that critics have called a Trojan horse for Social Security and Medicare cuts.

House Speaker Mike Johnson (R-La.), a longtime proponent of Social Security cuts, described such a commission as one of his top priorities after winning the gavel last month, and right-wing organizations such as the Koch-connected group FreedomWorks have endorsed the idea.

A fiscal commission of the kind backed by congressional Republi-

cans and some conservative Democrats—including Sen. Joe Manchin (D-W.Va.)—would be tasked with analyzing Social Security, Medicare, and other U.S. trust fund programs and developing policy recommendations ostensibly aimed at improving the programs' finances. The policy proposals would then be put on a fast track in both the House and Senate.

Social Security Works and other progressive organizations have stressed that Social Security does not add to the federal debt and warned against the growing push for a fiscal commission.

"That's code for a death panel designed to cut Social Security and Medicare behind closed doors," Social Security Works wrote in a social media post on Monday in response to the impending hearing.

"MAGA Mike Johnson and his fellow Republicans desperately want this commission to give bipartisan cover to benefit cuts," the group added. "Democrats must stand united against it."

The House Budget Committee's Wednesday hearing will feature testimony from Manchin and Sen. Mitt Romney (R-Utah), who earlier this month teamed up to introduce legislation that would establish a

16-member bipartisan, bicameral fiscal commission comprised of 12 elected officials and four outside experts.

Manchin and Romney have both said they're not running for reelection next year.

Alex Lawson, executive director of Social Security Works, called Manchin and Romney "cowards" who are "quitting and heading out of town, but want to set up a closed-door commission to cut Social Security and Medicare on the way out the door."

According to a legislative summary released by Manchin's office, the commission would "produce a report and propose a package of legislative solutions to improve the long-term fiscal condition of the federal government, stabilize the ratio of public debt to GDP within a 15-year period, and improve solvency of federal trust funds over a 75-year period."

"If the commission approves proposed legislative language, it would receive expedited consideration in both chambers," the summary continues. "While 60 votes would be required to invoke cloture prior to final passage in the Senate, only a simple majority would be needed for

the motion to proceed, which would be privileged."

Manchin and Romney's bill is one of three pieces of legislation that the House Budget Committee discussed during Wednesday's hearing. The committee is chaired by Rep. Jodey Arrington (R-Texas), a fiscal commission supporter and member of a Republican panel that called for raising the Social Security retirement age earlier this year.

Progressive lawmakers and organizations have argued that instead of cutting benefits, Congress could ensure Social Security is fully funded for the next seven-plus decades and expand benefits by lifting the payroll tax cap that allows the rich to avoid taxes on annual income over roughly \$160,000.

"All of the options for eliminating Social Security's projected shortfall, manageable in size and still a decade away, are fully understood," more than 100 advocacy groups wrote in a letter to members of Congress earlier this month. "The only reason to make changes to Social Security via a closed-door commission is to cut already modest earned benefits—something the American people overwhelmingly oppose—while



avoiding political accountability.

Corporate America Just Threw A Party Celebrating Tax Cuts For The Ultrarich

After narrowly avoiding a shutdown for the second time in less than two months, lawmakers went home to enjoy the Thanksgiving holiday without making sustained investments in the critical programs that empower millions of American families and enable our economy to thrive.

Programs that provide nutritional assistance to women and children or offer housing assistance will face multiple funding cliffs early in the new year because extremists in Congress are only interested in advancing the economic interests of the very rich—and partying with them.

Just hours after avoiding a shutdown, tax policy wonks, lawmakers, and staff, polished their shoes,

pressed their tuxedos, and attended "Tax Prom," an annual fundraiser to support the anti-tax Tax Foundation. The organization is a classic D.C. deficit squawk: it flies its Wall Street coop when big corporations want tax cuts, and screeches when it's time to invest in the rest of us.

For instance, the organization advocated for Presidents George W. Bush's and Donald Trump's tax cut packages, both of which were disproportionately skewed toward the very rich and large corporations, but lowered overall revenue to just 16.5 percent of GDP in fiscal year 2023 and caused the national deficit to grow.

On May 17th of this year, Scott Hodge, the organization's President Emeritus, seized on the growing debt to warn the Senate Budget Committee that "the only sustainable solution to stabilize the debt" isn't increasing revenue or ensuring the wealthiest among us pay their fair share in taxes—it's "controlling spending." In other words: cut Medicare, Social Security, and other critical programs working Americans rely on.

Sounds familiar, right?

And while it's no surprise to see conservative economic luminaries and corporate sponsors from big oil, pharma, and the tax prep industry attending and funding the annual celebration, the Foundation's ability to attract support from more progressive voices is more alarming.


In past years, the Foundation has honored Senate Finance Chairman Ron Wyden, former Senator Max Baucus, and Rep. Richard Neal. In 2023, it bestowed its distinguished service award on Sen. Maggie Hassan—the first time the Foundation celebrated an elected Democrat for "their efforts to advance sound tax policy" since 2016.

That may not be coincidental, since deficit squawks are building momentum for a new round of policies that benefit the ultrarich.

It comes at a time when our economy, powered by the administration's hard-fought public investments, continues its record-breaking recovery. Real economic growth was at 4.9 percent last quarter, unemployment is below 4 percent for the



Gov. Plays Dodge 'Em with School Funding To the Editor:

On November 20th, the Superior Court again ruled that New Hampshire does not provide sufficient funds to school districts to ensure that all students have the opportunity for an adequate education as required by the state's constitution. It also ruled that the administration of the Statewide Education Property Tax (SWEPT) does not meet the constitutional requirement that all taxes for a state purpose be equal in rate throughout the state.

Governor Sununu's response to this was to state "New Hampshire currently spends among the most per capita on public education than nearly any other state."

The Governor is correct. But that is not the issue. The plaintiffs in both court cases could concede that. The Governor did not address the fact that the State itself funds its schools at a lower rate than any other state. In doing so, it pushes the burden onto real estate owners to fund 70 percent of the total, resulting in highly unequal property tax rates among the towns.

The question that Governor Sununu and all candidates for governor should be asked is "How will you ensure that students in every zip code in New Hampshire receive an adequate education that is funded only by taxes with equal rates throughout the state?"

Governor Sununu also commented "Today's decision is deeply concerning and an overreach into a decades-long precedent appropriately placed in the hands of our elected representatives in Concord."The plaintiffs have sought relief from the court because no "decades-long precedent" can trump the state's constitution. The constitution appropriately places constraints on what elected representatives can and cannot do and they have chosen not to comply with those constraints. That is very scary.


That Famous First Casualty



Advocates of this view interpret the events in Gaza in terms of a struggle between oppressed Palestinians and their colonial Israeli oppressors. Although spurred by a desire for social justice, Postcolonialism is a narrowly dualistic philosophy that defines Israelis as evil and Palestinians as good. It admits no complexity nor nuance and consequently denies the humanity of the murdered Israelis. Let's be clear. A slaughter of innocents is not praiseworthy. The Oct. 7th attack was not carried out by brave freedom fighters nor selfless Jihadis. Unsuspecting civilian victims were indiscriminately cut down, women were raped then shot and innocent children were murdered. The attackers were brutal butchers who showed no mercy to helpless victims. Their mission was extermination not liberation. It is disturbing that the pampered professors and students at elite universities who praised the Hamas attack are so wrapped in a simplistic ideology that they cannot share a common humanity with massacred innocents.

Supporters of Israel are not immune to dogmatic interpretations. Many fall back on Cold War rhetoric contending that the U.S. needs to support Israel because it is an outpost of Western democracy among the autocratic regimes of the Middle East. This position, of course, ignores that Israel provides the full panel of civil rights only to its Jewish citizens. Muslim Palestinians are denied many basic rights and are treated as an underclass. In this regard, Israel resembles a theocracy as much as a Westernized democracy. The massive military response to the Hamas attack has been defended as Israel's right to defend itself. Yet, it has been estimated that the Israeli air force has dropped so many bombs on Gaza City that their firepower exceeds

the destructive power of two nuclear weapons. Much of Gaza City has been reduced to rubble. Over 11,000 innocent Gazan civilians have been killed, many of them children. Is this a reasonable price of self-defense? The IDF makes the ludicrous claim that they do not target civilians, but they know full well that the toll of the warfare they are conducting includes civilian carnage (collateral damage in the euphemism of modern warfare). Are the lives of innocent Gazans worth so much less than the lives of innocent Israelis?

Let's clear away the sophistries of both sides and recognize that a human tragedy is being played out in Gaza. It is a repetitive chapter in the saga of ancient atavistic hatred between tribes that has been a part of Middle Eastern history for thousands of years. Modern political and religious ideologies provide no reasonable justification for the inhumane actions of both sides. For many Israelis, the conflict is Joshua razing Jericho using modern tanks rather than Shofars. It is the IDF following an Old Testament imperative to exterminate the Canaanites to preserve the purity of Israelites. For the Palestinians, it is the defense of a sacred land unjustly taken from them by an ancient, hated invader. Neither muddled modern ideology nor religious mythology are adequate for either explaining or resolving these timeless conflicts. I opened this letter with a quote from Aeschylus. I close with lyrics written by 60's peace activist Pete Seeger. "Oh, when will you ever learn? Oh, when will you ever learn?"

You have brought up many a thorny issue here. These are bloody times, so let's grab a few.

You write of "pro-Palestinian advoca-

cy groups" praising "the Hamas attack as warranted resistance." We'll not deny that such groups exist. By focusing on them, though, are we not ignoring the middle ground occupied by those who abhore both the Hamas attack and illegal Israeli settlements? The side with power sets the terms—and condemns the powerless when they resist.

Speaking of the powerless, what of the Israelis who oppose the settlements? It seems to us there is a striking parallel here: both Israel and the U.S.—its No. 1 sponsor—have largely been driven for forty years by an increasingly demented right wing ideology. Perhaps it's no coincidence that both Netanyahu and Trump are corrupt bullies, dictators desperately hoping to avoid conviction.

Now that we're all scratched up and bloody, let's pick some nits. You suggest Aeschylus as the source of that memorable phrase. We checked it out. Nothing personal, that's our job.

According to QuoteInvestigator.com [QI], whom we hold as authoritative, your Greek pal wrote, "God is not averse to deceit in a just cause." It seems to us that the "just cause" stipulation would render the aphorism inapplicable in many recent cases.

The earliest use QI could find was in July, 1915. The San Diego [Calif.] Union quoted Ethel Annakin, the wife of the British politician Philip Snowden, saying "Someone has said that 'truth is the first casualty of warfare..."

The most accurate use of the expression can be found on a t-shirt: "The first casualty of war is truth. The rest are mostly civilians."

Get Out the Ouija Board

Dear Editor:

The Fourteenth Amendment to the Constitution of the United States (ratified in 1868, shortly after the Civil War) was intended to be an authoritative definition of what it means to be a citizen of the United States and to guarantee equal treatment to all persons under the law by requiring the states to abide by the Bill of Rights. Ironically, it wasn't until nearly 100 years later (in the 1960's) that most of the civil liberties outlined in the Bill of Rights were applied to the states.

The XIV Amendment has been contentious from the beginning. The first conflict occurred in 1896 when the infamous *Plessy v. Ferguson* decision asserted that "equal but separate accommodations" for blacks on railroad cars did not violate the "equal protection under the laws" clause. By defending the constitutionality of racial segregation, the Court paved the way for the repressive Jim Crow laws of the south.

Then there was *Gideon v. Wainwright* in 1963, having to do with "due process." Then, in 1996, in the *United States v. Virginia*, policies regarding women serving in the military were changed. Remaining unresolved, however, a woman's right to register for Selective Service.

Presently another constitutional crisis looms large on the framework of U.S. law and order in regard to the far-reaching XIV Amendment, which states very clearly in Section 3: "No person shall be a Senator or Representative in Congress, or elector of President and Vice-President, or hold any office, civil or military, under the United States, or under any state, who, having previously taken an oath, as a member of Congress, or as an officer of the United States, or as a member of any State legislature, or as an executive or judicial officer of any state, to support the Constitution of the United States, shall have engaged in insurrection or rebellion against the same, or gives aid or comfort to the enemies thereof."

This is the "Disqualification Clause" and, as Judge Sarah Wallace has ruled former President Donald Trump guilty of insurrection, in that he actively primed the anger of his supporters on January 6th, 2021 with the clear intent to incite political violence, and specifically directed that brute force at the Capital of the United States with the transparent and precise intent to overturn an election he knew he'd lost.

That act renders Donald Trump explicitly ineligible to hold office under the XIV Amendment.

However, even though the XIV Amendment appears crystal-clear, indisputably plain and the disqualifying clause seemingly specifically written to prevent men like Donald Trump from gaining power and dominance in a democratic form of government, a glitch exists (according to Judge Wallace) having to do with Trump being a former president.

We should view Donald Trump, not as a former president but in a simpler form as an ordinary citizen, a voter, an "elector," like you, like me. As such, under the conditions set forth in the XIV Amendment Section 3, Donald John Trump (an insurrectionist) is unqualified to hold any public office.



John Adams wrote in his A Defence of the Constitution of the United States in 1787: "In every society known to man, an aristocracy has risen up in the course of time, consisting of a few rich and honorable families who have united with each other against both the people and the first magistrate." Adams' skepticism about the stability of direct democracies led him to join in the effort to create a republic with protections against the excesses of the citizenry as well as their political leaders: three branches of government, a bicameral and representational Congress, a free press, etc. But, as the above quotation suggests, he feared most the capture of our republic by an oligarchy.

That same year in a letter to Thomas Jefferson, Adams wrote, "You are afraid of the one, I, of the few." It was not monarchy our democracy has to fear, he was telling Jefferson, so much as oligarchy. (Adams didn't live to witness our American mega-corporations, who are now, according to SCOTUS, "people" who are free to hire more lobbyists than we have senators and congressmen, or surely, Adams would have mentioned them as well).

Have we arrived at our oligarchic crisis? Or has the crisis passed: is the entrenched system of our political institutions no longer willing or capable of dismantling the American oligarchy? Can a single presidential candidate once in office successfully instigate the dismantling? We and the representatives we keep electing seem to have been so concerned with the welfare of the rich that it is hard to imagine our turn-

ing around at this late date and resetting a just balance. I'm a skeptic about our potential to begin to reset the balance toward dismantling the oligarchy, probably a project of 25 or more years of creative and brilliant work. Thankfulness Buried in the Rubble by Robert C. Koehler

Much as I love Thanksgiving—seeing my family... oh the turkey, oh the cranberry sauce—I feel like

maybe a bomb fragment has hit the "thanks" part.

I find myself struggling to let a sense of thankfulness flow, because when I do—and doing so has always been a crucial part of the holiday—suddenly my gratitude for the blessings of my life starts to feel more like luck and, even worse, privilege. Yeah, how nice. I'm thankful for the books in my library. I'm thankful for the air I breathe, for my daughter, my sister, my nieces and nephews and all the friendship, all the love, that fortifies my life. But then....

As I give thanks to the walls of my house, as I kiss the computer at which I sit, I hear bombs flying and suddenly I can envision all of it... all of it, all of it... being taken from me in an instant. I envision digging for a child in the rubble.

Yes, this current war that is saturating the media—Israel's assault on Gaza, funded by the United States, emerging from seven and a half decades of Israeli occupation of Palestine—has entered my consciousness in a way I can't seem to ignore. It's only one of several hellish wars fes-

tering on Planet Earth right now, but I can't stop hearing the Israeli defense minister seeming to explain all of them: "We are fighting human animals."

And once again, genocide is just and righteous and necessary. And history's soul cracks open. The story of Thanksgiving is two cultures embracing and sharing a feast of life. But then one of the cultures stole the continent. As *New York Times* reporter Maya Salam wrote some years ago: "Thanksgiving facts and Thanksgiving myths have blended together for years like so much gravy and mashed potatoes, and separating them is just as complicated."

Yeah, stir in the genocide. Stir in the slavery. The holiday starts renaming itself: Thankstaking.

Here's a frequently left-out fragment of the Thanksgiving story. It's the story of Tisquantum, also known as Squanto, a member of the Wampanoag tribe in the 1600s. He's known to be the Pilgrims' rescuer who, after half the Pilgrim settlers had died during a harsh winter, taught those who were left some necessary survival skills, including how to catch eel and grow corn.

But, according to *Potawatomi.org*, Tisquantum's story is "less innocent than the narrative that he assisted the Pilgrims with teaching them how to grow crops and take advantage of North America's bounties."

What's generally not mentioned in the classroom is that six years before the Mayflower arrived, in what is now known as Massachusetts, a slave-trader had captured Tisquantum, along with a group of Native Americans, who were taken as captives to Europe. Tisquantum eventually wound up escaping and made his way to England where he learned English. He returned to the American continent in 1619.

As the Potawatomi site explains:

"While Tisquantum was overseas, New England's Indigenous experienced a monumental death rate, with some communities losing nearly every tribal member to the decimating effects of European diseases.

"Upon returning to North American and his village of Patuset, Tisquantum found only piles of bones

A Poet in Palestine

By W.D. Ehrhart

Back in the spring of 2022, I wrote an essay titled "A Farewell to Arms" about a young Palestinian poet named Mosab Abu Toha who had just published a book called *Things You May Find Hidden in My Ear* (City Lights, 2022).

Mosab is a remarkable young man. Still in his very early 30s, he is married and the father of three children. He was a visiting poet at Harvard University in 2019-20 (during which time his youngest son was born, thus making Mostafa a U.S. citizen); founded the Edward Said Library, the first English-language public library in Gaza; and earned an MFA from Syracuse University just this year.

His collection of poems has won a Palestine Book Award and an American Book Award, and he was a finalist for the National Book Critics Circle Award. His poems and prose have been widely published in the *New Yorker*, *New York Times*, *Nation*, *Progressive*, *Atlantic* and elsewhere.

I first became aware of him and his writing through our mutual friend Professor Ammiel Alcalay of the CUNY Graduate Center and Queens College, a first-generation American and Sephardic Jew, and a specialist in Middle Eastern languages.

Alcalay has been in regular contact with Abu Toha since the events of October 7th, and has shared with me some of those communications,

which have been disturbing to say the least. In late October, his home was completely destroyed, and he and his family were forced to take refuge in a school in the Jabaliya refugee camp.

"I'm so heartbroken, so heartbroken, so heartbroken," he wrote on October 29th. "One of my students got killed, along with his father, grandfather, and grandmother. Wadee, my handsome, polite, and clever student doesn't deserve this. Nor the many thousands of Gazans. This is so cruel. We cannot bear to watch more lives ended."

"Still alive," he wrote on November 8th, "Just yesterday my three-year-old son, Mostafa, my brother-in-law Ahmad, and I survived death by chance. I was on my bike while Mostafa and Ahmad on another bike were returning to our shelter school when two bombs fell on a house just a hundred meters away. Rubble fell on us like a shower of rain. Mostafa and Ahmad were just ahead of me. I started biking madly in the street looking for them and crying. Thankfully they made it safe to school before me. This needs to stop!!!"

"We don't have any access to food or clean water," he wrote on November 16th. "Winter is coming and we don't have enough clothes. Kids are suffering. We are suffering. The army is now at Al-Shifa Hospital. More death, more destruction. Who can stop this? Please stop it now."

Then a few days later, Ammiel sent me this: "I'm Mosab's brother.

The army took Mosab when he arrived at the checkpoint leaving the north headed south to where the [Israeli] army had ordered [civilians] to move. His wife & children entered the south, but the army arrested my brother and we know nothing about him."

"...Mosab was taken with some 200 others, forced [at gunpoint] to give up his 3-year-old child he was holding.' For several suspenseful days, no one knew anything else."

"My understanding," Ammiel added, "Is that Mosab and his family were heading to Rafah in order to leave, having been cleared to do so by the U.S. Embassy. Today Ammiel wrote, "Mosab was released yesterday. He'd been taken with about 200 others, men & women, to a prison in the Negev, beaten & "questioned," &, my understanding is that he was then re-united with family (after the poor youngest, of course, was traumatized by having had to be handed over by Mosab to his wife as soldiers fired a few shots ("for fun," I guess) & took him away. So I'm not sure where they were re-united, in central Gaza, I think. My hunch is that they would try & wait for a ceasefire/truce deal before trying to move toward Rafah where, to my understanding, they

planned to exit to Egypt. But, of course, any of these things can turn on a dime at any second, given the utter terror being unleashed from the air, artillery, roving bands of soldiers picking people up, lack of food, water, clothing, shelter, etc."

My own guess is that Mosab was released because of pressure from major media outlets like the *New York Times* and the *New Yorker*, and organizations like PEN America. Mosab is a bright and rising star in the literary world, a public figure. He has a following, and strong advocates.

One can only wonder what will be the fate of the other 199 people who were rounded up with Mosab, and who do not have an international following. And the thousands of others like them.

Postscript: On November 24th, Mosab wrote, "I'm safe but I still have severe pain in my nose and teeth after being beaten by the Israeli army last Sunday. I gave them all my family's passports, including my American son's passport but they didn't return anything to me. Also my clothes and my children's were taken and not returned to me. No wallet, no money, no credit cards. Everything was confiscated. I'm in pain." That is the latest news I've been able to find.



of his fellow tribesmen killed by the plagues. He realized he was the sole survivor of his village. The illness spread so quickly that many local tribes never had time to bury their dead.

"Where Tisquantum's village once thrived, the Pilgrims established Plymouth Plantation."

Tisquantum—escaped slave, sole survivor (because of his capture) of a village wiped out by a plague bequeathed by the Europeans—helped the newcomers learn how to live in their new land. In 1621, the Pilgrims celebrated their successful harvest that year, along with the Wampanoag, who apparently considered themselves allies of the new arrivals. But they weren't. Instead,

genocide ensued.

Wamsutta (Frank) James, a founder of the movement declaring Thanksgiving to be a National Day of Mourning for Native Americans, said in a 1970 speech: "We, the Wampanoag, welcomed you, the white man, with open arms, little knowing that it was the beginning of the end."

All of which leads me back to the present moment, more or less. A day of thanks? A day of atonement?

As much as the human race has accomplished in the past several hundred thousand years, its evolution hasn't yet created global social sanity. Despite cries of outrage from the political margins, geopolitical civilization essentially remains organized around the principle of war and conquest: Fragments of humanity are still trying to destroy

one another. We're at a point where our destructive power is so great that we're on the brink of global suicide.

Sorry to bring this up just as the turkey's being served. So let me try to find my way back into a spirit of thankfulness, as much as I can muster in the shadow of looming genocide. I am thankful that Oregon Sen. Jeff Merkley recently doubled the number of U.S. senators calling for an Israeli ceasefire in the war—from one (Dick Durbin of Illinois) to two.

Merkley said:

"Most importantly, the Israeli people and the Palestinian people must find leaders determined to partner with each other and the world to replace the cycle of hate and violence with both a long-term vision for security, peace and prosperity featuring two states for two peoples, and immediate, concrete

Admiral Fowle's Piscataqua River Tidal Guide (Not for Navigational Purposes)

Portsmouth, arguably the first town in this country not founded by religious extremists, is bounded on the north and east by the Piscatagua River, the second, third. or fourth fastest-flowing navigable river in the country, depending on

whom you choose to believe. The Piscataqua's ferocious current is caused by the tide, which, in turn, is caused by the moon. The other player is a vast sunken valley Great Bay — about ten miles upriver. Twice a day, the moon

drags about seventeen billion gallons of seawater - enough to fill 2,125,000 tanker trucks — up the river and into Great Bay. This creates a roving hydraulic conflict, as incoming sea and the outgoing river collide. The skirmish line moves from the mouth of the river, up past New Castle, around the bend by the old Naval Prison, under Memorial Bridge, past the tugboats, and on into Great Bay. This can best be seen when the tide is rising.

The river also has its placid moments, around high and low tides. When the river rests, its tugboats

and bridges work their hardest. Ships coming in laden with coal, oil, and salt do so at high tide, for more clearance under their keels They leave empty, riding high in the water, at low tide, to squeeze under Memorial Bridge.
