No Cause For Alarm

ight days ago a criminal defendant, currently out on \$200,000 bail, sent a funny video to millions of his social media followers.

For the benefit of those who have not seen it, the video shows a huge black "dually" truck, with two wheels on each end of the back axle. The front wheels are secured by special lugnuts sporting long, chrome, gladiator-style spikes, the better to intimidate other drivers and pedestrians. The truck is so big it's got its own flagpole, carrying a 3 x 5 foot "Thin Blue Line" flag. Black and white, with a single blue stripe, it's meant to signify support for the police—not the law, but the police. With its non-standard colors, the flag's mere existence violates the U.S. Flag Code.

While some might find the truck itself laughable, the punchline is on the vinyl-wrapped tailgate. Through clever use of the painter's technique known as *trompe l'oile*, the tailgate creates the illusion of being invisible, or simply not present. This allows a full view of the truck bed, and what it seems to be carrying: President Joe Biden, lying on his side, bound and gagged like a kidnap victim.

If the poster of this video had just been some ordinary run-of-the-mill felon, up on charges of bank robbery or arson, this incident would be unremarkable. It was, however, Donald J. Trump, the self-professed "very stable genius" and acknowledged former President who is the führer of the cult known as the Republican Party and quite possibly the next President of the U.S.A.

A Home-Grown Cheerleader for Fascism

Despite having Windham, New Hampshire's very own Corey Lewandowski for his campaign manager in 2016, Donald Trump lost this state's four electoral votes to Hillary Clinton.

This time around, Trump has an Atkinson, New Hampshire native, Karoline Leavitt, as his national press secretary. Will the results be the same? One can only hope.

Lewandowski was notorious, eight years ago, for manhandling protestors and a woman reporting for Breitbart. While Leavitt has yet to show any predeliction for physical violence, she seems eager to make up for that through verbal bellicosity. Here she is talking about what Team Trump has planned for polling places in November:

"We have the team, now it's time to deploy the troops on the ground. ... We're gonna have soldiers, poll watchers on the ground who are making sure that there are no irregularities and fraud like we saw in the last election cycle."

All perfectly harmless, of course-mere metaphorical campaign rhetoric. Nothing to be alarmed about. It's not as if there's

any chance that some gun-totin' Trump follower would ever decide to strap on his Glock when he heads for the polls on election day.

Standing, Schmanding, or "Because We Say So'

The state of New Hampshire installed a historical marker in Concord last year, noting the birthplace of Elizabeth Gurley Flynn. It went up after Mary Lee Sargent and Arnie Alpert went through the usual lengthy process: research the subject, establish valid reasons why a marker would be appropriate, submit the application, and hope that the Division of Historical Resources verifies your argument and grants its approval.

Two weeks later the state removed the marker. Why? Because the Governor said so.

Sargent and Alpert took the case to court. They asked to have the marker re-installed. The court said no, justifying its decision by declaring that Sargent and Alpert "lack standing.'

After all, what do Sargent and Alpert have to do with Flynn's historical marker? Who do they think they are? Chris Sununu?

"Standing" is one of those legal terms that can cause confusion among mere mortals. When it comes to being lawyers, we plead not guilty, therefore we cannot explain it.

We do, however, edit a newspaper. We are therefore free to exercise our rights under the First Amendment. In our book—well, in our newspaper—"standing" is the legal equivalent of Silly Putty[™].

As evidence that our argument is valid we submit to the reader as evidence the

case of FDA v. Alliance for Hippocratic Medicine, now before the Supreme Court.

The Alliance for Hippocratic Medicine is a recently-assembled group of medical associations. None of them perform abortions. None of its member organizations work in Texas. Its mailing address is in Ten-

What the Alliance does have is a beef against the abortion pill mifepristone. According to the Progressive Caucus Center, the Alliance "alleged the FDA lacked the authority to approve mifepristone, that studies regarding drug's safety were insufficient, and that mifepristone's approval violates a 150-year-old anti-obscenity law...."

Tennessee, Texas—what's the difference? That was close enough for Judge Matthew J. Kacsmaryk, whom Donald J. Trump appointed to the U.S. District Court for the Northern District of Texas.

Bingo. Suddenly mifepristone proven for over 23 years to be both safe and effective—is verboten be-



cause the Alliance has standing.

Appeals of cases in Kacsmaryk's court are handled by the Fifth Circuit. One might expect the Fifth Circuit to notice that Tennessee is not in their district and throw out the case for lack of standing but

Surely, then, the Supreme Court will look at the case and say, "Can't anyone on the Fifth Circuit read a map? Dismissed for lack of standing."What fools ye editors be....

The paragraphs above exhaust our understanding—or misunderstanding—of legal standing. To mitigate the confusion they may have generated, we now offer a slightly truncated press release which we received from the litigants on Monday:

Flynn Marker Sponsors Ask Court to Reconsider Standing Issue

CONCORD, NEW HAMP-SHIRE—In a motion filed Friday by their attorney, Andru Volinsky, Mary Lee Sargent and Arnie Alpert have asked Merrimack County Superior Court Judge John Kissinger to reconsider his ruling that they lack standing to sue the State for removing a historical marker about Elizabeth Gurley Flynn.

Sargent and Alpert led an effort for the Division of Historical Resources (DHR) to install a marker near the Concord birthplace of Flynn, who gained notoriety as a labor activist, civil libertarian, and advocate for women's equality in the early twentieth century. Later, she became a leader of the Communist Party for which she was jailed under the Smith Act during the McCarthy

The Flynn marker was installed at the corner of Court and Montgomery Streets in Concord on May 1, 2023 but was taken down only two weeks later on the orders of Governor Chris Sununu, apparently on the grounds that Flynn's involvement in the Communist Party disqualified her from historical recognition.

When Sargent and Alpert sued the State in August, the Attorney General moved to have the case dismissed on the grounds that they

lacked legal standing. Judge Kissinger agreed.

"While no one disputes the time and effort expended by the plaintiffs in relation to the Flynn marker, the Court finds no support for a determination that such efforts give rise to a legal right interest, or privilege protected by law," Kissinger wrote in a March 20 order.

"The Court's ruling protects the decision to remove the marker no matter the reason," Volinsky wrote in the motion for reconsideration. "All removal decisions are protected from review by the Court's ruling on standing. No one could challenge a similar decision to remove a marker because the subject of the marker was a Republican or Democrat, woman, LGBTQIA, Black, Brown, Asian, or any other factor an executive councilor or a governor deems objectionable."

Volinsky's motion also reasserted his clients' views that their recognized status as the marker's sponsors gives them legal standing.

"The purpose of the marker program is educating the public about places, events, and people of historical significance, a category which certainly includes Elizabeth Gurley Flynn," said Mary Lee Sargent, a Bow resident who taught American history and women's studies at colleges and universities for several decades. "There is no provision in statute or in the rules governing the marker program that says established markers can be removed based on ideological rather than historical grounds."

If Judge Kissinger accepts the motion for reconsideration, the case would move to the discovery phase and perhaps to a trial. If the judge sticks to his previous opinion, the plaintiffs' only legal recourse would be an appeal to the N.H. Supreme

Born in Concord to an Irish immigrant family on August 7, 1890, Elizabeth Gurley Flynn was already a well-known speaker before reaching her twentieth birthday. As a member of the Industrial Workers

of the World, a labor union which sought to organize workers without regard to race, sex, or national origin, Flynn crisscrossed the country lifting the spirits of striking workers, raising funds for their defense, and helping to organize textile, mining, timber, and other workers to win better pay and working conditions. A staunch defender of women's equality, Flynn became a fierce defender of civil liberties during the first "Red Scare" and was among the founders of the American Civil Liberties Union.

At the age of 46, Flynn joined the Communist Party at a time the group was campaigning against fascism and promoting a "popular front" in support of President Franklin Roosevelt's New Deal. She soon rose to prominence within the party, for which she was indicted, tried, convicted, and sent to prison under the Smith Act.

It was Flynn's Communist affiliation which attracted the ire of Executive Councilor Joe Kenney, who two days after the marker was installed demanded it be removed. Governor Sununu agreed, and the marker was taken away by the Department of Transportation on May 15th. It is believed to be still in the custody of the Department of Transportation....

Abandoning, now, the orderly text of the press release, we'll resume our own barbaric editorial yawp to note that Flynn, though a commie, never tried to overthrow the government.

Sununu has stated on record, though, that he'll vote for Trump, who has.

"Let Them Eat GDP Reports":

44 Million Americans Are Food Insecure

U.S. anti-hunger group marked April Fools' Ďay on Monday with a snarky statement suggesting that hungry Americans "can eat positive economic statistics about the soaring stock market or the growing gross domestic product."

"Let them eat GDP reports," Hunger Free America declared of the 44 million Americans—including 13 million children—who live in food insecure households, according to the U.S. Department of Agricul-

GDP is the market value of all the finished goods and services produced in a country over a certain time period. Critics have long argued against using it as the premier indicator of how a nation is doing.

"The old school way of the elites fighting hunger was to say, 'let them eat cake," said Hunger Free America CEO Joel Berg. "But the more modern approach is to say, 'let them eat a report of the nation's growing GDP, although the report offers empty calories."

"By focusing mostly on economic statistics that benefit mostly the wealthy—like stock indices—the nation's political and media elites blithely overlook hard evidence that the economy is still structurally unsound for large swaths of the public, and then those same elites are flummoxed as to why the public tells pollsters they are still not satisfied with the economy,"Berg explained.

"But the good news is that, none of that matters now, because truckloads of positive economic reports are being shipped to food banks, soup kitchens, and food pantries nationwide, and the country's impoverished multitudes can now get all they can eat—assuming they can digest paper report pages and cardboard report covers, and don't mind a bit of poisonous ink," he quipped.

While inflation has eased in the United States over the past two years in the wake of the Covid-19 pandemic, corporations have engaged in price gouging that has kept costs high for Americans, everywhere from gas pumps to grocery stores to fast food restaurants.

"It's one thing for corporations to pass reasonable increased costs to consumers. It's another for them to line their coffers by exploiting Americans who are just trying to get by,"the Groundwork Collaborative's Liz Pancotti said in January, as the group released a related report. "It's time to rein in corporate price gouging—or families will continue to pay the price."

Data released last month by the Federal Reserve show that the top one percent of Americans are the richest they have ever been, with a collective \$44.6 trillion in wealth, a record largely driven by the stock market. President Joe Biden and some progressive Democratic lawmakers recently renewed calls for

wealth taxes, but such proposals are not expected to pass the divided Congress.

Meanwhile, the federal minimum wage is \$7.25 an hour, and has been so since 2009. Although state policymakers have taken ac-

tion to raise pay for some or all workers, national legislation to boost wages also has not been able to get through Congress.

GOP's Latest 'Clear Call to Genocide:' Rep. Calls for Nuclear Bombing of Gaza by Julia Conley

the latest Republican lawmaker to openly call for the genocide of Palestinian people in Gaza, saying at a town hall that instead of sending humanitarian aid to starving civilians there, the U.S. should "get it over quick" by dropping a nuclear bomb on the besieged enclave.

The Michigan Republican was asked by a voter why taxpayer money was being spent to build a port off the coast of Gaza at an event in the town of Dundee, in a video that was apparently recorded on March 25th and posted to social media on Saturday.

"We shouldn't be spending a dime on humanitarian aid. It should be like Nagasaki and Hiroshima," said Walberg, referring to the two Japanese cities where the U.S. detonated two atomic bombs in 1945, killing an estimated 214,000 people and leaving survivors with the effects of radiation, including chronic and deadly diseases.

Walberg's comments were made public a day after it was reported that the Biden administration had approved the transfer of new weapons to the Israel Defense Forces, including 2,000-pound bombs like those that have already made Israel's bombardment one of the deadliest and most destructive in modern his-

The White House has called on Israel to allow more humanitarian aid into Gaza, where at least 31 people—including 27 children—have already died of starvation as a result of Israel's near-total blockade on aid since October. Parts of northern Gaza are now experiencing famine, according to the Integrated Food Security Phase Classification global initiative (IPC), after months of warnings from experts that a manmade famine would eventually take hold unless humanitarian aid increased significantly.

The Israel Defense Forces' U.S.backed bombardment of the enclave has killed at least 32,705 Palestinians so far.

Dawud Walid, executive director of the Michigan chapter of the Council on American-Islamic Relations, said Walberg's "clear call to genocide... should be condemned by all Americans who value human life and international law.'

"To so casually call for what would result in the killing of every human being in Gaza sends the chilling message that Palestinian lives have no value," said Walid. "It is this dehumanization of the Palestinian people that has resulted in the ongoing slaughter and suffering we see every day in Gaza and the West Bank."

Mitchell Rivard, chief of staff to Rep. Dan Kildee (D-Mich.), said Walberg's comments illustrate "the Republican position on Gaza."

Earlier this month, Rep. Chuck Fleischmann (R-Tenn.) told a group of Palestinian rights advocates, "Goodbye to Palestine"—leading Rep. Becca Balint (D-Vt.) to say he had called "for the genocide of the Palestinian people."

Rep. Andy Ogles (R-Tenn.) in February told an activist, "I think we should kill 'em all," when asked about Palestinian children who have been killed by Israel with U.S. military support, while Sen. Lindsey Graham (R-S.C.) called for Israel to "level the place" soon after the war started.

New Video Details Billionaire Trump Donors Bankrolling RFK Jr.'s Run by Brett Wilkins

A video published March 26th by More Perfect Union sheds light on the ultrawealthy Republican donors to presumptive GOP nominee and former President Donald Trump's campaign coffers who are also financing Robert F. Kennedy Jr.'s independent White House run—which many observers see as a potential spoiler for President Joe Biden's reelection bid.

The video—which came as Ken-

nedy announced that California lawyer and philanthropist Nicole Shanahan is his running mate—underscores that the conspiracy theorist and former Democrat's biggest campaign contributor was also Trump's top donor in 2020.

"Who exactly is bankrolling RFK Jr.'s presidential push?" asked Brian Tyler Cohen, who narrates the seven-minute video. "It turns out the answer has a lot more to do with Trump than putting a Kennedy back in the White House."

Kennedy said that he had nothing to do with the multimillion-dollar ad supporting his campaign that aired during the Super Bowl last month.

"American Values 2024, a super political action committee (PAC) backing Kennedy, dropped a cool 7 million bucks for the spot, which about 124 million people saw," Cohen said. "And propping up American Values 2024 is a large group of big donors... a bunch of millionaires and billionaires who are driven by one goal: to get RFK Jr. on the ballot in all key states across the country."

"Doing a majority of the legwork here is the super PAC's biggest donor, Timothy Mellon," the video notes. "More than half of the \$38 million raised by American Values this cycle has come from Timothy Mellon alone."*

The video continues:

Mellon, who hails from the 34th-richest family in America, and likened anti-poverty programs to slavery, has long been a significant Republican donor. He's given tens of millions to Republican congressional super PACs. He's generously funded Trump's super PAC, Make America Great Again Inc., to the tune of \$16.5 million over the span of just two years. He was even Trump's top donor in 2020, and it doesn't look like he's going to stop tossing money at Trump anytime soon. His last donation of \$5 million to the pro-Trump PAC came on January 30, 2024. Just 22 days prior, he sent the same amount to

the pro-Kennedy PAC, making it pretty clear that Timothy Mellon doesn't want Kennedy, he knows Kennedy can spoil a Biden win, so he's keeping him afloat.

Boston Globe reporter Lissandra Villa de Petrzelka noted earlier this month that Mellon's donation record "is not linear."

"He has supported Democrats such as Sen. Joe Manchin, a centrist from West Virginia; progressive Rep. Alexandria Ocasio-Cortez of New York; and former Rep. Tulsi Gabbard of Hawaii and Sen. Kyrsten Sinema of Arizona, both Democrats before they left the party."

"But overwhelmingly, Mellon's money has funded conservative causes," she wrote. "According to *The Texas Tribune*, he donated millions in stock to Texas for a fundraising effort for a border wall. The *Wall Street Journal* reported he also donated more than a million dollars to a legal defense fund set up by Jan Brewer, then-governor of Arizona, for an immigration crackdown law that received national backlash and was partially struck down in the courts."

Mellon isn't the only GOP megadonor funding Kennedy's campaign. According to the video, billionaire security specialist and author Gavin de Becker has donated more money to Kennedy—\$10 million, so far—than to any other cause he's ever supported. Kennedy's campaign has paid de Becker's security firm \$1.9 million for services and travel expenses during the 2024 run.

Cohen said that "one of the more mysterious sources of funding" for American Values 2024 is Planeta Management LLC," which has given the super PAC \$4 million."

Because there is no listed name for the organization's leader on its filing papers, "we have no idea who the third-biggest donor to Kennedy' bid is," the video states.

"We do know his fourth-biggest donor, though," Cohen said. Leila Centner—who has supported Trump and disgraced former New



Islington Street, just about midnight.

York Republican Congressman George Santos—has given \$1 million to Kennedy's campaign.

The video notes that Centner is the co-founder and CEO of Centner Academy, a private school with a policy of "trying to keep teachers and staff from getting lifesaving Covid vaccinations" because she believes that "tens of thousands of women all over the world have had adverse effects including hemorrhaging and miscarriages just by being near someone who had the vaccine."

Perhaps the nation's most prominent vaccine skeptic, Kennedy told Fox News last year that he still believes the thoroughly debunked theory that vaccines cause autism. A 2019 measles epidemic in Samoa that killed scores of people, most of them children, has been linked to a prior visit by Kennedy in which he, his wife Cheryl Hines, and anti-vaccine activists spread deadly misinformation.

The DNC has a dubious history

of crushing third-party and independent challengers.

The new video notes that "all of these pro-Kennedy donations have so far been bearing fruit in a big way."

"With the help of American Values 2024, Kennedy has gotten on ballots in key states like Nevada and New Hampshire," Cohen said. "Additionally, he'll appear on the ballot in Hawaii and Utah... and Georgia, Arizona, and Michigan, three critical swing states with razor-thin margins."

"Kennedy's donors know that he'll never step foot in the White House, but that was never their goal," he added. "Their goal is to ensure that Trump does."



A Warning to Wannabe Dictators To the Editor:

That led to a civil war between the Cavaliers (ruling class) and the Roundheads (parliamentarians). Charles was captured, accused of treason, tried in a court of law, found guilty, and sentenced. The sentence was carried out in 1649. They chopped off his head. With those precedents, I would think more than twice about being a wannabe dictator.





Which Is It, Sen. Ayotte?

Dear Editor:

In her recent column in the Portsmouth Herald, former Senator Ayotte's words reminded me of the play Hamlet where Queen Gertrude states "The lady doth protest too much, methinks." Ms. Ayotte, twists herself into knots trying to declare her support for IVF while at the same time trying to distance herself from the recent Alabama IVF case. Unfortunately, Ms. Ayotte never addresses the key question. Does Ms. Ayotte believe that life begins at conception, which is the basis for the Alabama case? If she believes that life begins at conception, her statement regarding her support for IVF is not consistent with her true beliefs.

IVF involves the fertilization of multiple eggs resulting in the creation of a number of embryos. Since not all the embryos are actually implanted, the unused embryos are either kept frozen for future use or eventually destroyed. The Alabama Court decision declared that embryos were in fact "extra uterine children," and that destroying those unused embryos was committing a wrongful death. As such, anyone who believes that life begins at conception cannot at the same time state that they support IVF, since those unused embryos must be either kept frozen forever, which is not consistent with life, or, eventually destroyed.

Ms. Ayotte's record would indicate that she believes that life begins at conception. In 2010 then Senator Ayotte called for *Roe v. Wade* to be overturned, and in 2014, she led a group of 33 Republican senators demanding a vote on a national abortion ban. A national abortion ban would make abortion at any stage of gestation illegal thus codifying in law that life begins at conception.

Ms. Ayotte cannot have it both ways. Either she believes that life begins at conception and that unused embryos are "extra uterine children" that can never be destroyed and must be kept "alive" in a frozen state forever, or she does not. Her attempts to dance around the issue and obfuscate simply demonstrates how concerned she is about her previous record on abortion and the fallout from the Alabama ruling on her political future. However, she can quickly end this debate by clearly and unambiguously stating that she does not believe that life begins at conception and that embryos are not "extra uterine children." Only then can she legitimately claim that she truly supports IVF. Otherwise, her

Catalonia's Pro-Independence Movement Forces Spain To Approve An Amnesty To the Editor:

In the Middle Ages, Catalonia was one of the great European nations, but after 1714 it was subjugated by Castile (Madrid) and lost its sovereignty. The Spanish way of being (vertical, authoritarian, conquering and warlike) is opposed to the Catalan way (horizontal, pacifist, democratic, and merchant). That is why Catalonia has always tried to become independent, but Spain has violently prevented it. From 1939 to 1978, Spain had a fascist dictatorship, which was not defeated as in the case of Germany and Italy. The transition to democracy was not by conviction

but because the world demanded it, and it was very deficient. Since then, two major parties have alternated in power, PP from the right and PSOE from the center. The PP is the direct heir of fascism and the PSOE is the heir, by environmental osmosis, of the same intolerant nationalism.

Catalonia's ongoing independence attempt is the most powerful in history because now Spain cannot consider killing us in the institutional framework of the EU. In 2017 we held and won a self-determination referendum. The PP fought it using anti-democratic methods: judges, secret services, police... and now the PSOE is doing the same: repression and denial of any option towards freedom for Catalonia.

In the recent electoral campaign, the PSOE ridiculed Catalan independence, assured that it would arrest and lock up in prison Carles Puigdemont (the president of Catalonia who carried out the referendum in 2017 and who is in exile in Belgium) and denied the possibility of an amnesty for pro-independence criminals or any referendum on self-determination for Catalonia. The PSOE was showing off its chest by exhibiting the aggressive nationalism that is typical of the Spanish identity.

But the PP and the extreme right of VOX won the elections of July 23, 2023 without an absolute majority. Then the PSOE, seeing that it does not govern in any large region or city council, wanted to get the government of Spain so that its party has economic viability. And everything has changed. They no longer blaspheme the Catalan independentism, but they make a pact because they need their seven votes to govern.

On March 7th, the amnesty law that the PSOE said it would never approve was passed. And they have approved it with the Catalan pro-independence parties and other parties, in total eight parties (179 seats and 12.3 million

votes). It is a success for the Catalan independence movement because it has shown that they were falsely accused. Nobody would have been able to approve an amnesty that would pardon real terrorists. Spanish nationalism, in full fury, invented accusations against Catalan independence: rebellion, sedition, terrorism, treason, hate crimes, economic embezzlement.... But it is quite the opposite, the Catalan independence movement is exemplary in its democratic approach (it does not want to impose independence but has always wanted to hold a referendum of self-determination for the Catalan society to decide democratically) and it is not violent (it has made massive and peaceful mobilizations). Aware that there had been "lawfare" (judicial dirty war), the PSOE has now accepted an amnesty.

But the right and the extreme right do not want to accept the amnesty, because they see it as a defeat. They have always imposed themselves by force and now they do not want to accept the law passed by the Spanish parliament. The judges threaten to sabotage the law and not to apply it. And the fact is that, there being no crimes, an amnesty law is needed because the judges accept the invented accusations and condemn the pro-independence supporters to destroy this political movement. With that motivation, the judges will look for subterfuges not to apply it and to continue condemning.

And all this is because now the PSOE needs the seven pro-independence votes, but what will it do when it does not need them? What will it do when the Catalan pro-independence movement, remade from this chapter of repression, mobilizes again to free itself from Spain? We know: Both PP and PSOE will go back to repression. But for the moment, the independence movement has managed to demonstrate that it is not guilty of any crime and that it only wants freedom from a country that only increases the desire of the Catalans to free themselves from it.

The EU cannot continue tolerating these abuses and will have to intervene sooner or later, because the European

Justice is about to issue judgments against Spain (this imminence has also motivated the PSOE to approve the amnesty). In order not to waste time, or energy, or increase the Spanish institutional crisis, it would be better for the EU to force Spain to accept the result of the 2017 referendum or hold a new one in which the Catalans can decide their future free of impositions and authoritarianism.

Dear Editor,



But of course, large numbers of us are not, and over the past decade, Donald J. Trump has actually made it okay to be openly and flagrantly not diverse, equitable, and inclusive. Indeed, localities and whole states are now passing laws not only removing DEI programs, but making them illegal.

As for Critical Race Theory, well, that's never been taught anywhere but in law schools. What most people, especially CRT's critics, call CRT is actually something better known as history. Just plain history.

What actually happened. I've been teaching it for as long as I've been teaching history going back to my first history teaching job in 1981.

At the school where I taught most recently, there is presently a huge controversy generated by some students—no doubt supported by their parents—who have publicly complained that their opinions and points of view are being suppressed by liberal faculty members who discriminate against them because of their political conservativism. (What the current Republican party is conserving, I'd like to know, but that's a different debate.) That their grades are actually being lowered because of their political opinions.

I made no secret of my own political point of view when I was teaching. My classroom was festooned with posters of Marine Corps Major General Smedley Darlington Butler saying that he had spent his career as "a racketeer for capitalism," I.F. Stone declaring that "every government is run by liars and nothing they say should be believed," Laurel Thatcher Ulrich's assertion that "well-behaved women seldom make history," Scott Ritter's "I can train a monkey to wave an American flag; that does not make the monkey patriotic," a rainbow-colored triangle indicating a safe space for LGBTQs, and similar stuff. Lots of it.

I never had a student complain that I was discriminating against him because of his politics, or a student's parents either. But I wonder if that would still be true five years later. I wonder if students and their parents would still accept that I can accept their kids just as I find them,

Between the Snowflake Left Wingnuts who take offense at references to "the field" because it reminds them of slavery in the cotton fields, and the Snowflake Right Wingnuts who are convinced that reading Heather Has Two Mommies will convince their children to be gay, I don't think I would stand a chance of surviving two weeks in a high school classroom in the spring

Lucky for me, I don't have to try. But I feel sorry for the teachers who continue to try to navigate this educational minefield. And I feel really sorry for their students. I truly miss the daily contact with young people that kept me young in mind and spirit if not in body. But whenever I hear someone say that the solution to gun violence in our schools is to arm the teachers, or that academia has been commandeered by the communist, atheist, radical, revolutionary left, I am glad I got out of the classroom when I did.

Admiral Fowle's Piscataqua River Tidal Guide (Not for Navigational Purposes)

Portsmouth, arguably the first town in this country not founded by religious extremists, is bounded on the north and east by the Piscataqua River, the second, third, or fourth fastest-flowing navigable river in the country, depending on

whom you choose to believe. The Piscataqua's ferocious current is caused by the tide, which, in turn, is caused by the moon. The other player is a vast sunken valley Great Bay — about ten miles upriver. Twice a day, the moon

drags about seventeen billion gallons of seawater - enough to fill 2,125,000 tanker trucks — up the river and into Great Bay. This creates a roving hydraulic conflict, as incoming sea and the outgoing river collide. The skirmish line

moves from the mouth of the river, up past New Castle, around the bend by the old Naval Prison, under Memorial Bridge, past the tugboats, and on into Great Bay. This can best be seen when the tide is rising.

Twice a day, too, the moon lets all that water go. All the seawater that just fought its way upstream goes back home to the ocean. This is when the Piscataqua earns its title for xth fastest current, Look for the red buoy, at the upstream end of
